➤ **CREDIT AGREEMENT**

This application, if accepted by International Express Trucking, Inc. will constitute the binding agreement between the Applicant and International Express Trucking, Inc. pursuant to which International Express Trucking, Inc will extend credit and advance funds on behalf of Applicant for the payment of freight charges, custom duties etc., for consignments handled by International Express Trucking, Inc.

PAYMENT OF INTERNATIONAL EXPRESS TRUCKING INVOICES:

Payment is due upon receipt of International Express Trucking, Inc invoice. International Express Trucking, Inc may charge interest at 1.5% per month on accounts over 30 days.

In the event the shipment dispatched by Applicant is moved on a "collect" or "third party bill to" basis requiring International Express Trucking, Inc to collect the freight charges from the consignee, or from a third party, Applicant agrees to pay the freight charges in the event the consignee or third party fails or refuses to pay said charges after International Express Trucking, Inc , at International Express Trucking, Inc sole discretion, makes reasonable efforts to collect the freight charges from the consignee or third party.

CREDIT LINE:

Applicant understands and agrees credit will not be extended by International Express Trucking, Inc unless Applicant's account is current and the agreed credit line is not exceeded. International Express Trucking, Inc may cancel credit at any time and for any reason, without notice.

FEES:

In the event International Express Trucking, Inc retains legal counsel or other representation to collect the freight charges due from Applicant under the terms of this credit agreement, Applicant agrees to pay, in addition to any amounts otherwise due, all costs, expenses and reasonable attorneys' fee or representative fees incurred by International Express Trucking, Inc in connection with its collection efforts.

Any check returned for any reason, including but not limited to, due to insufficient funds, will be assessed a fee of \$30 and placed for collection.

International Express Trucking, Inc is authorized to obtain trade and bank references.

GRANTING OF CARRIER'S LIEN:

International Express Trucking, Inc shall have a general and continuing lien on any and all property of Applicant coming into International Express Trucking, Inc actual or constructive possession or control for monies owed International Express Trucking, Inc by Applicant with regard to the shipment on which the lien is claimed, a prior shipment or shipments and/or both.

GOVERNING LAW:

The terms of this credit application shall be governed by the laws of the State of North Carolina and in the event a dispute arises out of the terms of this credit application or in connection with the transportation services rendered by International Express Trucking, Inc, the Applicant stipulates and agrees to consent to the venue and jurisdiction of the state and/or federal courts of the State of North Carolina, which shall not be exclusive.

OTHER:

Failure of International Express Trucking, Inc to strictly enforce any of the terms contained herein shall not constitute a waiver of rights on subsequent breaches.
